He is senior to Sri.M.Anjaneya Murthy. Hence, his objection is not considered.
5]	Sri.K.Venkataiah, Principal, G.J.C, Kothagudem,Khammam district	He has requested to include his name in the seniority list of Principal since he has joined as Principal on 29.01.2007.	His name is already included in the seniority list at Sl.No.27.
6]	Smt.Ch.Vinaya Kumari, Principal, Government Junior College, Sangem, Warangal district	She has requested to include her in the seniority list of Principals since she has joined as Principal on 15.06.2006	Her name was already included in the Seniority list at Sl.No.14.
7]	Sri.Syed.Zaheer Ahmed, Principal, Government Junior College, Burgampahad, Khammam district	He has submitted that his name was placed at Sl.No1355 in the integrated seniority list. He was awarded with the punishment of censure vide C.I.E`s Proc, dt.09.09.2010 and subsequently, he has made appeal before Government and Government has setasided the orders of the C.I.E in G.O.Rt.No.61, HE(IE.I) Department, dt.01.02.2011. Now, he has requested to restore his seniority in the cadre of Principals on par with his juniors who were promoted subsequently. Subsequently, the D.P.C to the post of Principals for the panel year 2011-2012 was conducted

He was exonerated from charges vide D.I.E`s Proc, dt.24.09.2009. In the mean time, his juniors were promoted as Principals. He was promoted as Principal after 25 months of period passed after his juniors promoted as Principals. He has requested to issue notional seniority in the cadre of Principal w.e.f.12.09.2008 from the date of his juniors promoted as Principals.	The name of Sri.P.Nageswara Rao was not considered to the post of Principal for the panel year 2008-2009 since charges were pending against him at that point of time. His next junior Sri.M.V.Gona Reddy, Junior Lecturer in English was promoted as Principal and posted to Government Junior College, Midjil, Mahabubnagar district and he joined duty on 12.09.2008. Subsequently, the D.P.C to the post of Principals for the panel year 2010-2011 was conducted and Sri.P.Nageswara Rao, Junior Lecturer in English was promoted as Principal vide D.I.E`s Proc, dt.07.10.2010 and he was posted at Government Junior College, Tungaturthy, Nalgonda district.
