In pursuance of the orders issued by the Commissioner of
Intermediate Education A. P. Hyderabad vide proceedings 1st & 2nd cited, the
provisional seniority list of Junior Lecturers appointed on adhoc basis through
APPSC (DR) during 2012 was communicated vide this office letter 6th read above,
inviting the objections as to their seniority and other particulars if any, subject to
the final outcome of the pending cases in the Hon'ble Supreme court of India / High
Court of Andhra Pradesh / A.P.A.T, pending antecedents and the Govt. orders if
any. Accordingly certain Junior Lecturers submitted their objections through the
Principals under the reference 7th read above. If any adverse remarks received in
case of pending antecedents suitable disciplinary proceedings will be initiated
against the individuals as per rules in force.

In the Govt. orders 2nd read above, the Govt. has issued amendment
orders for rule 9 of the A.P.I.E.S.R issued in G. O. Ms. No. 302 Edn, Dt.30-12-1993.
As per the amendment orders of the Govt. for the Andhra Pradesh Intermediate
Education Service Rules, the condition of passing the Departmental Tests prescribed
in Sub-Rule1 of Rule 9 has been substituted, accordingly the final seniority of the
Junior Lecturers is now communicated.

After careful examination of the representations over the errors on
particulars and the objections over the seniority received from the individual
Lecturers under rule 33 to 36 of AP State and Subordinate Service Rules 1996, the
final seniority hereby communicated subject to the condition of final outcome of the
cases in the Hon'ble Supreme Court of India/High Court of Andhra Pradesh/APAT,
Hyderabad and the Govt. Orders if any.

The Principals concerned are requested to communicate the seniority
list duly obtaining acknowledgement from the concerned JLs and submit to this
office.
